

The SMWL Foundation continues to support needs of 501(c)3 Public Charities in the Southern Maryland area.

The Board voted to give small grants to the following: Sisters Lifting Sisters Retreat; Sponsor the Walk to End Homelessness coordinated by Lifestyles of Southern Maryland; and Donate to the Youth Group of

In addition to Small Grants, the Foundation voted to replace 10 broken dressers, two armoires and two beds at the Angel's Watch Shelter.

New Life Church in their efforts to help stop Human Trafficking of

It is noted, that due to an innocent error with YWLP, the Foundation cannot continue to fund their projects. The coordinators of the group were assured YWLP was a 501(c)3 non-profit by the Board of Education. However, the organization, through the Board of Education is a taxexempt charity under section 115(1) of the Internal Revenue Code, not the 501(c)3 Code. This was discovered when they were asked to provide a copy of their 501(c)3 Letter from the IRS, prior to us funding one of the bigger events, Rachel's Challenge and they did not have that letter. Even some representatives of the Board of Education thought they were such an entity and told Milton Somers school that they indeed were a 501(c)3 public charity.

There are many different types of tax-exempt non-profits; but the designation of a Tax-exempt non-profit (public charity) under Section 501(c)3 of the Internal Revenue Code is very difficult to obtain.

SMWL Foundation By-Laws and Articles of Incorporation state that it will only donate funds to another 501(c)3 Public Charity.

However, in good faith, the Board voted to write the check directly to Rachel's Challenge which is a 501(c)3 Non-profit (public charity). The Foundation funded the \$2,200.00 YWLP originally requested for this event at their school.

Having said all of this, there is still a tremendous opportunity for the ladies of SMWL to mentor these young ladies and attend their events. One such event was the Rachel's Challenge 'Chain Reaction' Anti-Bully program recently held at Milton Somers Middle School on November 28, 2012 – and -- we were proud to have provided Rachel's Challenge with \$2,200 to be the major sponsor of this important event.

And, one exciting new piece of news...SMWL Membership voted almost unanimously to sponsor the Yellow Mediterranean Bedroom Suite for terminal patients at the Charles County Hospice House to make a lasting impression from our club and share our compassion and support for families within our community. We have the opportunity to pay for the room over five years. The suite will have an attractive and permanent plaque on the outside wall of the suite with our name on it; and we have the opportunity to personalize things within the room with SMWL's "touch". This opportunity is awesome and will help SMWL leave a lasting legacy....a goal that we have discussed wanting to accomplish repeatedly.
